As Democrats Rise In Virginia, So Does Intra-Party Distrust

The tensions resonate nationally: How much is the party committed to diversity and inclusion, versus protecting incumbents and the establishment?

JOAN WALSH

As Virginia's Democratic gubernatorial primary approached this spring, Josh Stanfield, campaign manager for Democratic Socialist Delegate Lee Carter, began to worry that state party officials and the Department of Elections weren't treating all candidates equally. Among other worries, he'd heard that some establishment candidates got different (and more accurate) instructions for submitting their nominating petitions than Carter did. That matters, because the first to file is first on the ballot, which research shows can provide a slight advantage. As it turned out, front-runner and former governor Terry McAuliffe wound up at the top of the June 8 ballot; Carter is fourth of five.

Stanfield filed a Freedom of Information Act (FOIA) request with the Elections Department to see if he could find out what happened. He didn't. But he found out other things. Among the documents Stanfield received were several having to do not with Carter but with another primary election controversy—over whether party officials had been fair to three Black progressives, all challenging Democratic House of Delegates incumbents, who were disqualified by the State Board of Elections for problems with filing required paperwork, including a statement of qualifications and another on their economic interests. (I wrote about the controversy here.)

The documents Stanfield received suggested the answer was no.

All three, indeed, had filing problems, each of them different, but candidates have routinely been given a chance to fix them, under a state-sanctioned 10-day grace period. This year, for the first time in memory, they were not. Richmond City Council member the Rev. Mike Jones, Arlington activist Matt Rogers, and Dumfries Town Council member Cydny Neville found their campaigns, already in full swing, abruptly terminated, their names barred from the June primary ballot. Virginia's NAACP blasted "the appearance of disparate treatment of candidates of color...who sought to challenge incumbent legislators."

There was another level of alleged unfairness, though: The three candidates, and others, had heard about Virginia Democratic Party officials' working with the Department of Elections to find out which candidates had paperwork problems, so they could fix them by the deadline—but the three challengers never got such help. There were rumors of a "spreadsheet" being used to track compliance. I wrote about this earlier this month, and when I asked party officials about those reports, I was told there was no such operation; Democratic Party staffers had merely helped with internal party business, including verifying nominating petitions, but not with whether candidates had filed their state-mandated Certificate of Candidate Qualifications (CCQ) or Statement of Economic Interest (SOEI), also known as an ethics statement.

The House Democratic Caucus, I was told, had the job of communicating with all candidates on those two issues. But caucus sources told me they only work with their members—who are by definition, incumbents—so it wasn't their job to help challengers. It looked rather like an incumbent-protection racket, but at least they were all being honest about it.

Among Stanfield's FOIA documents, however, were two spreadsheets that focused on exactly those questions, as well as communications between Elections Department staffers and the party's political director, Shyam Raman. On March 8, Raman e-mailed the Department of Elections's Paul Saunders with the subject line "Happy Filing Day." His message read: "As we go through these 17 days [before the filing deadline] are you able to send us the Democratic Candidates who have submitted their SOEI and CCQ? Just so we can track them and make sure nobody misses out on anything." (To reiterate: Those are the filings the Virginia Democratic Party says it doesn't work with candidates on.) Saunders submitted information every few days. As the March 25 final filing deadline approached, Raman again e-mailed Saunders: "Would you be able to send this updated list today, tomorrow, and wednesday? And if possible, mid-day thursday? I want to be sure everyone gets their paperwork in the mail by 5pm on the 25th." The updates then came daily. Throughout the long e-mail chain, there is no mention of passing the spreadsheets on to the House Democratic Caucus so that they could reach out to candidates; Raman repeatedly says "we" or "I" are making sure "everyone gets their paperwork in" by the deadline.

Saunders and his supervisor at the Department of Elections David Nichols didn't reply to requests for comment.

Now that we have the FOIA documents, this seems more obviously a case of party misbehavior. But it's still hard to tease out. I don't want to make a villain of Raman, who referred my questions to the state party's communications director, Grant Fox. Whatever Raman did was at the behest of party leaders. And the seemingly incriminating e-mail doesn't prove the information wasn't shared with the caucus. Indeed, party officials continue to tell me that, despite what the documents appear to say, they were not working directly with candidates on their qualifications or ethics statements; that's the caucus's job.

To tell the truth, for a while, I felt a little like I was being gas-lighted—I thought of the old expression, "Who are you going to believe, me or your lying eyes?" No one would ever discuss the FOIA documents with me, e-mail by e-mail, one by one. But I'm not comfortable calling anyone I spoke to a liar.

Still, the questions raised by what all parties admit was a major political mess remain vexing. The release of the FOIA documents renewed the ire of the three excluded candidates, weeks after they were disqualified. "The results of the FOIA speak for themselves," Neville texted me crisply, though she declined to comment further. "It's NOT good," Jones wrote. Rogers thought it was proof that party officials had lied about not directly working to clear up other candidates' paperwork.

But all three decided against mounting any legal challenge that might have—no guarantees, and who knows the expense—reversed the Board of Elections decision. State Board of Elections Chair Bob Brink, a longtime Virginia Democratic leader, talked to me freely for my last story, but he did not return requests for comment on this one. As I write, ballots are being printed without the three challengers' names. This story is over. Jones, who is always funny and smart, answered his phone Monday by saying, "You know the old Boys2Men song: 'We've come to the end of the road.'" Apparently, it's the end of the road for these three candidates.

This story has gotten scant local news attention. But it raises nationally resonant questions about how much Democratic Party institutions are committed to inclusion, versus protecting incumbents and the party establishment.

"Knocking on doors in Richmond's African American neighborhoods, the main reason I heard for people not voting is that they think it's all rigged," Jones told me dejectedly.

"The loyalty here should be to Democrats, not to incumbents," he continues. "To truly eliminate bias—whether in terms of race, economics or incumbency—you need a fair, equitable, and transparent process. This wasn't it. This was cronyism." Jones thinks candidates should be able to file their documents online, and check regularly to make sure they were submitted correctly. "We do everything else that way, why not this?"

Stanfield agreed. "This is typical party-machine manipulation," the longtime Activate Virginia activist told me. "You have an asymmetry of information between establishment candidates and outsiders."

In his case, Carter's campaign and its leaders, with others, had gone to court to get party officials to let supporters sign nominating petitions digitally because of Covid. They got a consent decree backing them. Then they were told the state Department of Elections would also create a way to file those petitions online instead of in person. But according to Stanfield, it never happened. "We just kept hitting 'refresh, refresh, refresh," on the website they were told to use on filing day, he says. It never worked. Thus Carter wound up filing later than three of the five candidates running for governor, putting him behind them on the ballot.

In the case of the disqualified delegate candidates, it didn't pretty up the situation that all three are Black. That's not necessarily because of racism: There are certainly other Black candidates who made the Democratic delegate ballot, and three of Virginia's five Democratic gubernatorial candidates are Black. (All are far behind McAuliffe in current polls, as is Carter.)

But as I argued in my last piece, race plays out in these decisions nonetheless. We know from experience that some of the best opportunities to elect BIPOC and female leaders, as well as progressives, from the city council to Congress, will come in solidly Democratic districts, like the ones in Virginia where the three Black challengers to more moderate Democratic incumbents wound up being blocked from the ballot. The successful primary challenges of Boston's Ayanna Pressley, New York's Alexandria Ocasio-Cortez, and St. Louis's Cori Bush come to mind (as does the resistance of some Democratic Party congressional leaders to those Democratic primary challengers).

The party's commitment to diversity, inclusion, and growing its base can only be served by promoting fairness to candidates who are outsiders, even if challenging incumbents. Which sometimes hurts. I get it.

But excluding promising candidates of color will, in the long run, hurt more. How many voters of color, in those three districts, have been denied a choice between the challenger and an incumbent? Dr. Fergie Reid Jr., founder of the voting rights and candidate recruitment group 90 for 90, estimates it's about 80,000. (And of course plenty of white voters would like a choice, too.)

At the end of my last piece, I quoted Virginia Democratic Party Executive Director Andrew Whitley acknowledging the confusion. "We have to make sure we don't have a replication of this again," Whitley told me. The conflict over the FOIA documents made that task more urgent, Communications Director Fox reiterated Monday afternoon. "We have to make sure whatever process we go through next time, this doesn't happen again."

Let's hope so, because it's not clear state party leaders could have designed a process more likely to sow distrust if they tried to. Virginia has been a bellwether of the post-Trump Democratic revival. We should all learn from not just from its successes but als0 its mistakes. And learn too, I hope, when the state fixes them.

Danville Democrat who was denied nomination asks state Department of Elections to put her on the ballot

Democrats have refused to nominate Jasmine Lipscomb for a House of Delegates seat after a dispute over a filing fee.

A U.S. Marine Corps veteran from Danville who has been denied the Democratic nomination by her own party in the 49th House of Delegates District after clashing with local party officials over voter signatures and filing fees has asked the Virginia Department of Elections to place her on the ballot for the November election.

Jasmine Lipscomb, a 37-year-old Black single mother of four, wrote in an email to Elections Administration Supervisor Paul Saunders on Tuesday that she has handed over all the required paperwork with the exception of <u>Form 511</u> — the certification of a non-primary candidate — which she said "should have been submitted" by the district's Democratic nominating committee.

In her email Lipscomb renewed her allegations from a complaint she filed earlier this month against the party's leadership, accusing her district's nominating committee of "discrimination based on economic status," that the panel that had denied her the nomination "was improperly constituted" and that its decision "should be given no weight."

"Unfortunately, the Democratic HD 49 Nominating Committee was illegitimate according to the Democratic Party of Virginia's rules and regulations (aka The Democratic Party of Virginia Party Plan), and because of this fact, that nominating committee's conclusions can not be relied upon by you and the Department of Elections," Lipscomb wrote.

The newly created 49th District includes Danville and parts of Pittsylvania and Halifax counties. Data from the Virginia Public Access Project shows that the district is 53% white and 45% minority, including 40.1% Black. The incumbent is Del. Danny Marshall, R-Danville, a former race car driver who was first elected to the House of Delegates in 2001.

Because Democrats did not nominate a candidate by the June 20 deadline — the day of the most recent primary election — Marshall isn't scheduled to face opposition in the general election this fall. The deadline for the party to submit a candidate's paperwork to the Virginia Department of Elections to make the ballot passed Monday.

Lipscomb said in an interview with Cardinal News that she won't run in November unless her name is on the ballot as the Democratic nominee. "I'm not doing a write-in campaign, and I am not running as an independent. I'm a Democrat, and I'm not going away," she said.

Lipscomb's <u>ongoing feud</u> with party officials began shortly after she first threw her hat into the ring in spring.

In her first meeting with the district's nominating committee in April, the local chairs — Tina Younger of Halifax, Roy Ford Jr. of Pittsylvania and Patricia Harper-Tunley, who also chairs the neighboring Lunenburg County committee — informed Lipscomb of the requirements and the nomination process, which included a \$500 filing fee and a petition of 100 signatures to be submitted by 5 p.m. May 20. The committee issued a call to caucus on May 14, setting the date for May 27.

However, because Lipscomb was unable to come up with the \$500 filing fee, she did not submit the signatures. Consequently, the committee **canceled** the caucus meeting and announced that there would be no Democrat seeking election in the district this year — despite the fact that political parties in Virginia are allowed to nominate a candidate on their own through individual party committees by June 20.

The committee's announcement set off a flurry of emails between Lipscomb and Harper-Tunley. During the exchange, she stated that as the sole Democrat seeking the nomination she didn't believe the filing fee was necessary, citing Section 10.6 in the Democratic Party of Virginia **Party Plan** that grants the district committee the authority to nominate a candidate by acclamation if no candidate has been nominated for office via a caucus.

Harper-Tunley and the other committee members disagreed, and the feud soon spilled over to social media, creating a public spectacle with undertones of racial discrimination that Democrats were hoping to avoid in an election year. Lipscomb eventually submitted the \$500 filing fee, which she received from a donor, and the required signatures, but the committee rejected both, arguing that it was too late.

"As you can see in the emails, I communicated that I subsequently received the \$500 donation from an angel donor and was told by Patricia Harper-Tunley that it was too late and no candidate would be nominated. This is discrimination based on economic status," Lipscomb wrote in her complaint to the party.

But the complaint also alleges that the committee had no standing in the first place because the panel's rightful chair, Danville Democratic Chair Clem Oliver, had relinquished her duties as chair of the nominating committee to Harper-Tunley for health reasons.

The complaint also cites Section 7.4 of the party plan, which states that "the General Assembly District Committees shall consist of the chairs of the county or city committees in whose counties or cities the district lies."

But because Harper-Tunley does not live within the boundaries of the 49th District, the complaint argues that she should be prohibited from serving as the district's committee chair, as should Ford, Jr., the chair of Pittsylvania committee, who lives in the 48th District.

Harper-Tunley did not respond to a phone call seeking comment on Tuesday. Liam Watson, a spokesman for the Democratic Party of Virginia, also declined to comment. When asked about how the party handles formal complaints, like Lipscomb's, Watson referred to Section 5.6 of the party plan, which requires the DPVA Chair Susan Swecker to appoint a subcommittee comprising members of the party's Steering Committee to review each formal complaint.

If the subcommittee finds that there is a reasonable basis for the complaint, "it shall immediately begin an investigation" and file "a written report within thirty (30) days of the filing." Within 30 days of receiving the subcommittee report, the Steering Committee "shall act on the complaint and provide such remedies, as it deems appropriate."

Stephen Farnsworth, a political scientist at the University of Mary Washington, said that the feud between Lipscomb and her local nominating committee, and now the Democratic Party of Virginia, was a rare event in Virginia politics.

"Normally parties will take the one candidate they have, if they only have one. Part of the reason this story has gotten the national attention it has is because the local Democratic organization is saying that not having a candidate is better than having a candidate, which is a very unusual position for a party or organization to take," Farnsworth said.

Lipscomb's complaint to the party was amplified upon its filing by two Democratic candidates for the state Senate.

Pam Garner, a retired lieutenant colonel in the U.S. Air Force who is the party's nominee in Senate District 26 (which stretches from the Richmond suburbs to the Chesapeake Bay), and Myra Payne, a retired lieutenant colonel in the U.S. Army and the nominee in Senate District 19 (which includes parts of Chesapeake and Virginia Beach), said in a **joint statement** published on the Black Virginia News Substack that the party's actions against Lipscomb "not only undermine the integrity of the caucus but also contradict the principles of inclusivity and equal opportunity" that the Democratic Party upholds.

"We firmly believe that this incident warrants immediate attention to rectify the injustice faced by Jasmine Lipscomb," the two nominees said in the statement.

The remedy, they suggest, is that the Virginia Democratic Party declare Lipscomb the nominee. "It is our request that you take appropriate measures to ensure that the Party Plan is adhered to consistently and without bias in future caucus proceedings. Additionally, we urge you to extend a formal apology to Ms. Lipscomb for the distress and discrimination she has endured," they said.

However, with Monday's deadline passed, it is no longer in the hands of the Democratic Party to put a candidate on the ballot. But the Virginia State Board of Elections may choose to consider Lipscomb's complaint and approve her request when it meets again next week.

This isn't without precedent. In June 2021, Del. Dave LaRock, R-Loudoun County — who recently lost his bid to become the Republican nominee in the newly created 1st state Senate District — <u>asked</u> the State Board of Elections for reprieve after a local Republican Party official submitted his paperwork as an uncontested primary candidate two days late. The board agreed to take up the case and later granted LaRock's request to place him on the ballot despite the missed deadline.


And in 2019, the board <u>accepted</u> late party nomination paperwork for Del. Terry Kilgore, R-Scott County, so he would be listed on the ballot as the Republican candidate that year. Kilgore was the winner of a local party convention, which should have allowed him to make the ballot as the official GOP nominee. But a snag in the delivery process resulted in a missed filing deadline.

However, in these cases both candidates had enjoyed the support of their local nominating committees, which is a somewhat different scenario, said Farnsworth, the political scientist.

"The few times that we've had a roughly compatible situation was when a party organization has backed the person using the late paperwork excuse," Farnsworth said. "If the would-be candidate could get the backing of the party before the next meeting of the State Board of Elections, getting on the ballot would probably happen. But if the party was going to accept the candidate, it probably would have happened by now."

Despite the different circumstances, Lipscomb is holding out hope that the elections board will take up her case and rule in her favor, just as it has done with the aforementioned Republican candidates.

"Although the reasons ... differ slightly, the result is the same; will the tens of thousands of voters in each of these districts have an opportunity to participate in 'small d' democracy, or will they be deprived of a choice on their ballot due to the failings of a local nominating committee?" she wrote in her email to elections officials. "I am asking for the same remedy that you provided for Mr. LaRock, Mr. Kilgore, and the tens of thousands of voters in each of their districts."



Tomorrow, July 5, you are supposedly holding a meeting and will discuss Jasmine's complaint and her request to be put on the ballot. Trevor Southerland, Zach Pruckowski, and Thomas "Jordan" Miles have been vocal about this issue on Twitter, and I wonder whether Zach and Jordan speak for DPVA, the nominating committee, and the Party since they are members of DPVA leadership.

Not nominating Jasmine highlights not only the injustice and harm to the Democratic Party of not running a Democrat against a Republican incumbent, but also a flaw in the way DPVA leadership runs its elections and nominations process. I draw your attention to Sections 7.4, 7.5, and 10.6 of the DPVA Party Plan.

I've put the story here in a nutshell:

- Jasmine filed proper and timely paperwork to run for Delegate for House District 49. She has receipts.
 Although she filed after the deadline to qualify for the Primary, she filed before the final June 20 deadline.
- She met with the nominating committee members <u>Patricia Harper-Tunley</u>, <u>Tina Wyatt Younger</u>, and <u>Roy Ford</u>, <u>Jr.</u> However, that committee was formed in violation of the Party Plan, Section 7.4, because Patricia and Roy do not reside in HD49. They reside in HD50 and HD48, respectively.
- The committee placed an usual caucus requirement on Jasmine to submit a non-refundable \$500 fee and 100 signatures. No other caucus candidate was required to submit as much as \$500 or any signatures.
- Jasmine could not raise the \$500 by the committee's deadline and, therefore, did not get 100 signatures. It is reasonable not to get signatures when the committee would not accept them without the \$500 fee.
- Jasmine knows the rules and reminded the committee that the \$500 was not necessary because of the
 provision in Section 10.6 of the Party Plan. Therefore, because she could not raise the \$500, she asked
 the committee to name her the nominee per Section 10.6.
- 6. My guess is that the committee took umbrage that she would ask to be nominated by acclamation and took it to mean that she refused to follow the rules and "do the work." This is far from the truth. The inability to raise \$500 is not a refusal to follow the rules.
- A committee that prides itself on following the rules and chastised Jasmine for breaking them and trying to cut corners broke their own rules – Section 7.4 of the Party Plan.

Their actions hurt not only the Democratic Party of Virginia, but also my Senate campaign and Democratic campaigns in surrounding districts. I am running for Senator in District 9, and House District 49 lies within my Senate district. House candidates on the ballot help Senate candidates on the ballot. With no Democratic challenger to the Republican incumbent in HD49, the GOP can spend more money against Democrats who are challenging Republicans in surrounding districts.

Berry says mistake may keep her off ballot

Democratic nominee for the 9th State Senate Trudy Berry says a mistake out of her control may be the end

of her campaign.

Berry, a citizen of
Lunenburg County who
is challenging incumbent
Sen. Frank Ruff said she
performed her candidate
duties by filing all the
required paperwork on
time, and the Department
of Elections accepted them
all. However, she says, her
nominating committee did
not properly perform their
duty to ensure that the
Department of Elections
received Form 527.

According to Berry, she has been denied ballot qualification because the Department of Elections has not received a document that officially certifies her status as her party's nominee after her local nominating committee accidentally sent it to the wrong email address.

"I called the department and verified that they received all of my forms, but not the 527," Berry said, referring to the Party Certification of Primary Candidates form. "I also verified with my registrar that she received my Statement of Organization. All of the paperwork I was required to submit was received and in order," she said.

In addition, according to an email shared with The K-V Dispatch, Berry

received an email from
Patricia Harper-Tunley, the
chair of the Lunenburg
County Democrats. On
April 3, Harper-Tunley
wrote that her signatures
had been certified and the
certification notice would
be submitted as required.

"From April 3 to July
13, everyone thought everything was in order and
my name would be on the
ballot," Berry said. "When
Patricia looked for the

receipt of submission of the 527 form, she noticed that the email address was incomplete," Berry said. "This is why the Department of Elections had not received the 527."

In an interview on Monday, July
17, Berry said she is in a "wait and
see mode" to see if the "error will be
excused and they will allow my name
to be placed on the ballot."

to submit Form 527 to the Department of Elections has gone unanswered.

"That email is the key factor that will play in the Board of Election's decision to put my name on the ballot," she said. "Did they, or did they not, attempt to submit Form 527? I have heard nothing more from Patricia Harper-Tunley and nothing from DPVA Political Director Jack Foley and Executive Director Shyam Raman."

The K-V Dispatch reached out to Harper-Tunley to request a copy of the email but was told, "The State Board of Elections (SBE) has been made aware of the issue. I do not have any additional information to provide at this time." Harper-Tunley said.

In addition, Harper-Tunley said the

email in question has been submitted to SBE and it can be requested from that agency.

Berry said the whole issue came to light after the official candidate list was published on the Department of Election's website.

Since Berry has heard nothing from her nominating committee Chair or Co-Chair, she submitted a letter to the Department of Elections on July 15 asking "that you allow my name to be placed on the ballot due to this error that was beyond my control and clearly the responsibility of my nominating committee Chair and Co-Chair."

In 2021, the Board of Elections allowed Delegate Dave LaRock (R) to appear on the ballot after local party officials missed a filing deadline to formally nominate him for office.

Berry is now asking for the same.

Four Democrats may not make the ballot because of paperwork problems


"I called the department and verified that they received all of my forms, but not the 527," Berry said, referring to the <u>Party</u> <u>Certification of Primary Candidates form.</u> "I also verified with my registrar that she received my Statement of Organization. All of the paperwork I was required to submit was received and in order," she said.

Berry added that she received an email from Patricia Harper-Tunley, the chair of the Lunenburg County Democrats, on April 3 stating that her signatures had been certified and the certification notice would be submitted as required. "This was before the April 6 deadline to file for the Primary Election. From April 3 to July 13 everyone thought everything was in order and my name would be on the ballot," she said.



For Democrats, who are seeking to keep their 22-18 edge in the Senate while hoping to flip the Republican majority in the House of Delegates, every seat is crucial.


And Berry isn't the only Democrat whose ballot qualification is in question due to missing documents.

The State Board of Elections recently denied a request for a filing extension to Dan Tomlinson of Louisa County, the only remaining Democrat seeking his party's nomination in the newly created 10th Senate District in central Virginia after Jacob Boykin withdrew his bid.

Because Tomlinson missed the deadline, the Republican nominee John McGuire, who currently represents Goochland County in the House of Delegates, is currently unopposed in the November election.

Greg Maxwell, the Democratic nominee in the 39th House of Delegates district in Franklin County and part of Roanoke County, has also asked the Department of Elections for an extension after his paperwork got lost in the mail. His case is still pending, and Maxwell declined to comment Friday.

In the 49th District, which includes Danville and parts of Pittsylvania and Halifax counties, U.S. Marine Corps veteran Jasmine Lipscomb is **still fighting** to get on the ballot after local party officials denied her the Democratic nomination because of a dispute over voter signatures and filing fees.

More Democrats in other parts of the state are facing similar challenges.

In House District 74, which includes parts of Chesterfield County and the city of Colonial Heights, Jessica Rowlands filed her paperwork without a statement of economic interest. And in House District 98, which encompasses parts of Virginia Beach, Zach Coltrain – at 20, the youngest candidate to run in the 2023 elections – submitted all of his required documents, but the local nominating committee did not send it in.

"During these last two weeks, between the candidate filing deadlines and the Department of Elections' official certification of party nominees, Virginia Republicans have successfully placed more than several candidates in

House and Senate contests, while in the same time period Virginia Democrats have been bleeding candidates in more than several House and the Senate contests," said Dr. Fergie Reid, Jr., the founder of the 90 For 90 voting rights initiative and the son of Dr. Fergie Reid, Sr., who in 1967 was the first Black politician to be elected to the Virginia General Assembly since the days of Reconstruction.

"All of this is an unforced error on the part of the DPVA and the Democratic House and Senate Caucuses. It's frustrating," Reid said.

Although I and other candidates have expressed our objections regarding committee conduct and conflicts of interest to Prince William County Democratic Committee (PWCDC) Chairwoman Tonya James on multiple occasions between 2022-2023, I am writing to **appeal** to DPVA to uphold its values by setting aside PWCDC's nomination of Rozia Henson (hereby referred to as "**Henson**"), Former Senior Vice Chair of PWCDC and Candidate/current Democratic Nominee for Virginia's newly drawn 19th House District (VA HD-19). Furthermore, I ask that you consider nominating me, Makya Little (hereby referred to as "**Little**"), for VA HD-19 based on the following known facts and observations which are counter to our Party values and written policies:

- PWCDC leadership pre-selected who their nominee would be and colluded with members of the Fairfax County Democratic Committee (FCDC) and other organizations while violating party rules in a manner that manipulated voters to ensure their desired outcome.
- PWCDC leadership utilized misleading sample ballots distributed by official committee personnel/leaders in official committee gear resulting in a **49 vote Little primary loss**.

- Henson leveraged the work of PWCDC as his personal "resume" while soliciting endorsements and support from organizations providing financial and human resources.
- PWCDC Chairperson continued to operate in official committee role while also serving
 as Campaign Manager for a Democratic candidate with a primary challenger, allowed
 Henson to maintain his role as Senior Vice Chair after filing to challenge Little in a
 primary stating that it was "poor practice but not against policy," and blocked the
 membership of committee members with an expressed desire to challenge preferred
 candidates in other primary races.
- PWCDC leadership adjusted the ballot qualification filing time (from 12pm to 7pm) to accommodate Henson.
- PWCDC leadership manipulated membership access to committees by way of broken/non-functioning website forms, and failed to ensure timely follow-up for residents desiring committee membership.
- FCDC leadership repeatedly allowed the deletion/removal of communications by Little on committee district's social media group page and provided an erroneous meeting date during final primary campaign weeks.
- PWCDC leadership manipulated other candidates, elected officials, local business owners, organizations etc. into endorsing/supporting Henson and/or withholding support for Little.
- PWCDC leadership took extensive actions—to include harassing a local business owner and non-profit organizational leadership—to cancel a bilingual community voter registration drive they believed would benefit Little.

Not only do these actions go against the will of the people and their ability to choose their elected officials and control their political destiny, they also disenfranchise the **87,222 residents** of VA HD-19 since there is currently no Republican or Independent challenger for the seat. Furthermore, these actions—many of which violate Section 10.11 and Section 13.2 of the Democratic Party of Virginia Party Plan—have caused personal harm to me and my family's finances by negatively impacting our ability to recoup personal investments made in our campaign through fundraising.

Therefore, on behalf of the 87,222 residents who essentially had 4-6 "leaders" within DPVA unilaterally decide who their representative would be—to include myself, Makya Little—I request as relief:

- Set aside the VA HD-19 nomination of Henson for his misuse of position, committee resources, and committee relationships.
- Submit Little as the Democratic nominee for VA HD-19 to Virginia's Department of Elections.

In seeking clarification of the rules from the Department of Elections, I believe you have the ability to execute this relief request in the near future. Therefore, I appreciate your prompt responsiveness in advance regarding this matter. As a life-long dedicated Democrat, I believe it is important for our nation to maintain their hope in our commitment to stand for "People over Politics," and that this relief is in the best interest of the people we have committed to serve.

Thanks again for your service to our democracy and consideration.

Virginia elections board certifies primary results, denies extension for late filers

Officials ignore plea from Democratic candidate who claims 49-vote loss was illegitimate

The State Board of Elections certified the results of Virginia's legislative primaries Wednesday in a unanimous, drama-free vote despite a handful of political controversies lingering after the June 20 elections.

The certification vote means state election officials have now officially declared former Republican state senator Glen Sturtevant the winner in his GOP primary battle against Sen. Amanda Chase, R-Chesterfield, in a Richmond-area district where Chase has been threatening to file a legal challenge.

Chase has been asking supporters to donate money to help her fight the result while indicating Wednesday was the deadline to file a challenge. She did not appear at the state board meeting to raise any objections in person to Sturtevant being certified as the winner.

In an Independence Day-themed fundraising solicitation this week, Chase indicated she had raised nearly \$12,000 for the effort.

"To date, we've raised enough money to cover the retainer and our attorneys are in good faith moving forward, but we will still have to pay their hourly fee and expenses," Chase's email blast read.

Online court records gave no indication Chase had filed a legal challenge as of Wednesday afternoon. In a news release Wednesday evening, Chase said she had emailed a complaint to the state board on Wednesday morning and hand-delivered a copy Wednesday afternoon after the certification vote had occurred.

Her complaint centers largely on the Chesterfield County Republican Committee's selection of Sturtevant campaign official as an official party observer to watch the testing of ballot scanners used in the 45-day early voting window. Chase's complaint acknowledges state law largely lets parties operate on an "honor system" where fair treatment of candidates is expected but not always legally mandated. The senator requested a hand recount of ballots cast via early voting and a "full forensic audit," but neither process is envisioned in state law. State election officials did not take up Chase's complaint Wednesday and it's unclear if they intend to do so.

The state elections board also denied a request for a 10-day filing extension that could have helped a handful of would-be candidates who had missed paperwork deadlines. That move also appeared to shut the door for good on two prospective Democratic candidates who allege their party treated them unfairly.

Democrat Makya Little, who narrowly lost a Northern Virginia House of Delegates primary to winner Rozia Henson, addressed the board in person, claiming local party leaders had skewed the contest and caused her to lose by 49 votes. Little alleged Democratic leaders in Prince William and Fairfax counties "manipulated voters to ensure their desired outcome" by allowing party officials to be involved with other candidates' campaigns, deleting her social media posts from party pages, canceling a "bilingual voter drive" and masterminding endorsements against her.

"For these reasons, I'm asking for an extension to run as an independent on the ballot since I had no good-faith opportunity to qualify as a Democrat," Little said.

It's unclear whether Little's request was legally possible due to Virginia's so-called "sore loser law" that prohibits a candidate from being on the ballot as an independent after failing to win their party's nomination in a primary. The board took no action in response to Little and spent no time discussing her allegations.

Tonya James, the chair of the Prince William County Democratic Committee, said it was the Democratic voters of the 19th House District who "chose their candidate."

"Our committee will not entertain the disenfranchisement of those voters for exercising their right to vote," James said.

Some Democrats have also been pushing for a last-minute reprieve for Jasmine Lipscomb, a Democratic military veteran who was trying to run against Del. Danny Marshall, R-Danville, but was denied the nomination after clashing with local Democratic organizers over the rules for a party-run nominating method.

After Democrats rebuffed her efforts to become the party's nominee despite her failure to meet the party's requirements for a \$500 filing fee and 100 voter signatures, Lipscomb and her allies have been suggesting the state board could intervene and put her on the ballot anyway. The board did not discuss Lipscomb's predicament on Wednesday and no one spoke on her behalf.

A half-dozen other General Assembly hopefuls, mostly independents and candidates running longshot campaigns, had requested a filing extension that would have allowed them to appear on the ballot despite paperwork problems. Like Lipscomb, a few of those candidates were urging the board to err on the side of giving voters more options, not less.

Democrat Daniel Tomlinson, who was attempting to challenge Del. John McGuire, R-Goochland, in a Republican-heavy Senate district outside Richmond, asked the board for leniency and said his paperwork issues were his own doing.

"I must say I have no excuse," Tomlinson said, noting he was a first-time candidate unfamiliar with the process. "This was a rookie mistake that I made while trying to keep up with the myriad demands that were imposed on me."

Though the board had granted a similar extension in April for candidates filing to run in the primaries, the board did not grant an extension for the June 20 deadline.

"When somebody asks for a late extension, to some degree you disenfranchise the folks that did follow the rules," said Board of Elections Chairman John O'Bannon, a Republican.

Jessica Rowland, a Democrat hoping to run against Del. Mike Cherry, R-Colonial Heights, also did not meet all filing requirements, according to election officials, and seemingly won't appear on the ballot due to the board's refusal to grant an extension.

Board member Matthew Weinstein, a Democrat, suggested having the Department of Elections do an internal study on paperwork issues and when filing extensions have and haven't been granted with a goal of coming up with clearer guidance on what its policies are moving forward.

"I think it might be helpful for people to kind of have a set of expectations going into it," Weinstein said.

Elections Commissioner Susan Beals indicated the department would conduct such a study.



State Board of Elections takes no action on Danville Democrat's request to get on the ballot

The board also took no action on requests by a Northern Virginia Democrat to be placed on the ballot as an independent and by a central Virginia Democrat who was late with his state Senate paperwork.

The Virginia State Board of Elections took no action at its meeting Wednesday on a request by Jasmine Lipscomb, a U.S. Marine Corps veteran from Danville who had asked the board to put her name on the ballot for the November election as the Democratic nominee in the 49th House of Delegates District after her own party had denied her the nomination.

Lipscomb informed Elections Administration Supervisor Paul Saunders <u>in an email last week</u> that she had handed over all the required paperwork with the exception of <u>Form 511</u> — the certification of a non-primary candidate — which she said "should have been submitted" by the district's Democratic nominating committee.

Lipscomb, who did not attend Wednesday's board meeting, said in a phone interview that she is now weighing her legal options.

"I am waiting to see what details will come out officially from the meeting. Based on that, I will make my decision on my next legal steps that I will take," Lipscomb said. "I will continue with the fight, I will not give up."

The newly created 49th District includes Danville and parts of Pittsylvania and Halifax counties. The incumbent is Del. Danny Marshall, R-Danville, who was first elected to the House of Delegates in 2001.

In the spring, Lipscomb clashed with local party officials over voter signatures and filing fees, and in her email to the elections board she renewed allegations she made in a complaint that she filed earlier this month against the Democratic party's leadership, accusing her district's nominating committee of "discrimination based on economic status" and saying that the panel that had denied her the nomination "was improperly constituted" and that its decision "should be given no weight."

The Democratic Nominating Committee in the 49th District had rejected Lipscomb's bid in May because she had missed the deadline to submit a petition with 100 signatures from voters in the district and the \$500 filing fee, which she did not have at the time.

Because Lipscomb didn't make it on the primary ballot, Marshall — the Republican incumbent — will run unopposed in the general election in a district that is 53% white and 45% minority, including 40.1% Black, according to data from the Virginia Public Access Project.

However, Lipscomb, a 37-year-old Black single mother of four, later submitted all required paperwork — including the filing fee — and argued that the party could still nominate her by acclamation even past the initial nomination deadline because she was the only candidate seeking the nomination. She also alleged that the committee had no standing in the first place because the panel's rightful chair, Danville Democratic Chair Clem Oliver, had relinquished her duties as chair of the nominating committee to Patricia Harper-Tunley for health reasons.

Lipscomb contended that Harper-Tunley, who chairs the neighboring Lunenburg County committee, should be prohibited from serving as the district's nominating committee chair because she does not live within the district boundaries. She cited Section 7.4 of the party plan, which states that "the General Assembly District Committees shall consist of the chairs of the county or city committees in whose counties or cities the district lies."

Leadership of the Democratic Party of Virginia has not publicly commented on Lipscomb's claims. A spokesman also declined to comment on Wednesday's board meeting.

Lispscomb said in the phone interview Wednesday that she wasn't surprised that the State Board of Elections did not take any action to aid her request.


"But I want to make clear that they allowed Republicans Kilgore and LaRock to have extensions on their 511s that were not submitted by the deadline. So it's interesting that the Democrats don't get that same opportunity," Lipscomb said, referring to the board's decision to accept late nomination paperwork for Del. Terry Kilgore, R-Scott County, in 2019, and two years later for Del. Dave LaRock, R-Loudoun County, who recently lost his bid to become the Republican nominee in the newly created 1st state Senate District.

But Lispcomb received public statements of support from other Democratic candidates.

On Tuesday, Trudy Berry — the Democratic nominee in the 9th State Senate District — said that the actions of the Democratic nominating committee in the 49th District not only hurt the Democratic Party of Virginia, but also her own Senate campaign, because House District 49 lies within her Senate district.

"House candidates on the ballot help Senate candidates on the ballot. With no Democratic challenger to the Republican incumbent in HD49, the GOP can spend more money against Democrats who are challenging Republicans in surrounding districts," Berry said in an email Tuesday.

"It is a travesty that this illegitimate nominating committee has disenfranchised the voters of HD49, and Democrats across the commonwealth are aware of it and feeling the pain."

Lipscomb isn't the only Black woman who has filed a complaint with the Democratic Party of Virginia this year.

Makya Little, who was seeking the Democratic nomination in the 19th House District in Northern Virginia but was defeated by Rozia Henson in a three-way primary by just 49 votes, alleges in a complaint she filed Monday with DPVA Chair Susan Swecker that the Prince William County Democratic Committee had "preselected who their nominee would be" and "colluded with members of the Fairfax County Democratic Committee and other organizations while violating party rules in a manner that manipulated voters to ensure their desired outcome."

In a phone interview Wednesday, Little said that the most recent events — including Lipscomb's unsuccessful attempts at getting her party's nomination — led her to conclude that the Democratic Party of Virginia "has an issue" with Black women in leadership roles.

"They want us for our labor, they want us for our support, they want us to help maintain power, yet when we choose to take on a leadership role — unless we're willing to be controlled — they literally work against us," Little said. "And then we wonder why we see the erosion of rights because people see things, and they choose not to say anything out of the sense of protection, because we want to keep that unity. And we are essentially forced to choose the lesser of two evils, regarding the two parties."

A DPVA spokesman declined to comment on Little's allegation. However, the party currently has several Black women in leadership roles, including Sen. Louise Lucas, D-Portsmouth, who is the Senate's president pro tempore; Del. Charniele Herring, D-Alexandra, the Democratic House caucus chair; and former state Sen. Jennifer McClellan, D-Richmond, who was recently elected as the first Black woman from Virginia to serve in Congress, representing the 4th Congressional District.

In her complaint, Little is asking Swecker to "consider nominating me" as the Democratic candidate in the 19th District, which includes parts of Prince William and Fairfax counties.

But unlike Lipscomb, who said that she would not run a write-in campaign or ask to be put on the ballot as an independent, Little on Wednesday asked the State Board of Elections for ballot access as an independent in a district where no Republican candidate has filed to run.


"Because the Democrats essentially did not run a fair process, I have a case to state that I never had a chance to qualify on the ballot as a Democrat, therefore extending the deadline would allow me to qualify as an independent," Little said in the interview.

But the board took no action on Little's request Wednesday. Saunders, the elections administration supervisor, said in a brief interview after the meeting that the board's consideration was for deadline extensions for two specific documents: the certificate of candidate qualification and the statement of economic interest. "They don't have statutory authority to take a stand for any other reason," Saunders said.

Little said that she is now considering taking her case to court in order to get ballot access as an independent candidate.

The board also did not grant a filing extension to Dan Tomlinson of Louisa County, the only remaining Democrat seeking his party's nomination in the newly created 10th Senate District in central Virginia after Jacob Boykin withdrew his bid.

Because Tomlinson missed the deadline, the Republican nominee John McGuire, who currently represents Goochland County in the House of Delegates, is currently unopposed in the November election.



Primary results are certified

The State Board of Elections met Wednesday to certify election results and hear from potential candidates who were seeking an extension on paperwork filing.

Former state Sen. Glen Sturtevant (R) has been formally certified as the June 20 SD-12 primary election winner. He beat the incumbent, Sen. Amanda Chase (R), by less than 400 votes. Chase has been fundraising since her loss to try and legally fight the results, she says, but she only filed a complaint with the State Elections Board Wednesday. She hand-delivered her complaint

after the vote was final. "Just submitted a physical copy of our official complaint to the Virginia State Board of Elections. Needless to say we were not welcome," she said in a video on Facebook.

Chase also says she plans to <u>launch a write in campaign</u> this fall.

Makya Little spoke to the Board also and asked them to allow her to run as an Independent after she lost the HD-19 Democratic primary to Rozia Henson.

From <u>Virginia Mercury's coverage</u> of the meeting: "Little alleged Democratic leaders in Prince William and Fairfax counties 'manipulated voters to ensure their desired outcome' by allowing party officials to be involved with other candidates' campaigns, deleting her social media posts from party pages, canceling a 'bilingual voter drive' and masterminding endorsements against her. 'For these reasons, I'm asking for an extension to run as an independent on the ballot since I had no good-faith opportunity to qualify as a Democrat."

The board took no action on Little's request.

The board also took no action for Democrat Janice Lipscomb who was trying to run against Del. Danny Marshall (R) but failed to complete the administrative process in time for the deadline with the party.

The board denied an extension for several candidates who failed to submit paperwork on time. Jessica Rowland (D), who was trying to run against Del. Mike Cherry (R), Daniel Tomlinson (D), who was trying to run against John McGuire (R), and Eric Sundberg (I), who was trying to run against Rae Cousins (D), did not receive an extension.

General Assembly remains at odds over budget talks - WCVE

Members of Virginia's General Assembly have had a list of state budget recommendations from Gov. Glenn Youngkin, but lawmakers remain at odds on how to best utilize the Commonwealth's more than \$3.5 billion surplus. When Youngkin first introduced his budget proposal, he called for \$1 billion in

tax cuts for residents and businesses, including a reduction of the corporate income tax rate from 6% to 5%.

The Republican-controlled House of Delegates approved a budget bill that aligns with the governor's proposed amendments, while the majority-Democrat Senate remains opposed to the governor's long-term tax cut strategy.

Minimal changes in Virginia housing law as affordability crisis continues - WCVE

New housing laws that went into effect July 1 made small changes to renters' rights and landlords' responsibilities, advocates and legislators told VPM News. "I didn't see anything that I would say harmed tenants, I didn't see much that would help tenants either," said Martin Wegbreit, litigation director at the Central Virginia Legal Aid Society.

CVLAS provides free civil legal aid, which includes extensive work on housing and evictions. Gov. Glenn Youngkin's "Make Virginia Home" housing plan, which was released just before the 2023 General Assembly session, targets increasing housing supply by loosening regulations on land use and zoning. Major legislation on housing proved to be a hard ask, though, since Republicans controlled the House and Democrats controlled the Senate.

Reeves, who received Jenkins' endorsement in the past and is a Culpeper County sheriff's deputy, said the accusations are a "huge surprise."



